## Filing a Concurrent Coverage or Priority of Payment Case

#### **Incident Details and My Party Information page**

In order to file a case under the Concurrent Coverage/Priority of Payment right of recovery, the user must choose the appropriate Coverage Group on the Incident Details and My Party Information page. The user must then enter the Concurrent Coverage/Priority of Payment Right of Recovery option.

#### **Review and Submit Page**

On the Review and Submit page, the user can review the information he or she has entered, validation errors, if any, and the evidence entered on the case. Once all validation errors have been addressed, the user can proceed to submit the case.

### **Responding to a Concurrent Coverage or Priority of Payment Case**

The user can identify a Concurrent Coverage/Priority of Payment case on the worklist by the "CC" badge displayed next to the Case ID. This badge is also displayed on the Case Header on all pages of the case.

#### **Coverage Response Page**

If there is a contract or policy in effect at the time of loss and coverage is not denied, the user can proceed to Feature Response page for Collision, Comprehensive/OTC. For PIP and Med Pay, the user will be required to enter their Per-Person Policy Limit on this page.

When coverage is denied, the user must provide a denial justification.

In Concurrent Coverage/Priority of Payment, if Contract or Coverage is denied, the Responding party will not be able to enter their own feature(s) for recovery.

The Responding Party deductible and remaining policy limits amounts are fields that are specific to Concurrent Coverage/Priority of Payment. These fields will help the arbitrator decide the policy limits available for an injured party or if a Responding party deductible amount is applicable to the award amount. It is recommended that the user attach evidence in support of their assertions or denials on the Feature Response page.
